**PROJECT LOCATION:** Southwest Corner of Tahquitz Canyon Way and Farrell Drive, City of Palm Springs, Riverside County

**PROJECT DESCRIPTION:** The College of the Desert/Desert Community College District (District) proposes to update and amend the West Valley Campus (WVC) Development Plan Project (Amd. No. 1) for the subject 27.94± acres previously occupied by the Palm Springs Mall, which was demolished in 2019. All but one parcel in the planning area (Palm Springs Cultural Center /Camelot Festival Theaters) is owned by the District and is included to ensure compatibility.

**FINDINGS/DETERMINATION:** The West Valley Campus Development Plan Amd. No. 1 (DPA No. 1) Project is designed to accommodate an enrollment of approximately 1,100 FTES and 121,025± square feet of functional space. Development will occur over 2-3 years, which may allow completed portions of the campus to become operational as development progresses. The DPA No. 1 Project changes and updates the physical planning framework, and reconfigures the distribution of buildings, parking and other facilities.

It has been determined that a Subsequent Environmental Impact Report (SEIR) should be prepared to evaluate the potential environmental effects of the new DPA No. 1 Project. At this time and based on the location and characteristics of the proposed Project, the SEIR will include analysis of potentially significant effects on the environment related to the following topics: Aesthetic and Scenic Resources, Air Quality and Greenhouse Gas, Biological and Cultural Resources, Geology and Soils, Land Use Compatibility, Noise, Transportation/Circulation, Hazards/Hazardous Materials, Hydrology and Water Quality, Noise, Public Services and Facilities, Population and Housing.



**PUBLIC REVIEW PERIOD:** A 30-day public review period for the Notice of Preparation (NOP) will commence at 8:00 a.m. on December 6, 2023 and end on January 5, 2024 at 5:00 p.m. for interested individuals and public agencies to submit written comments. A virtual scoping meeting will be held on December 19, 2023 at 1:30 p.m. via Zoom to learn more about this proposed Project and provide comments on the possible environmental effects the District should study in the SEIR.
